(And that's why lawyers by and large essentially become politicians and are always referred to as "counselors")



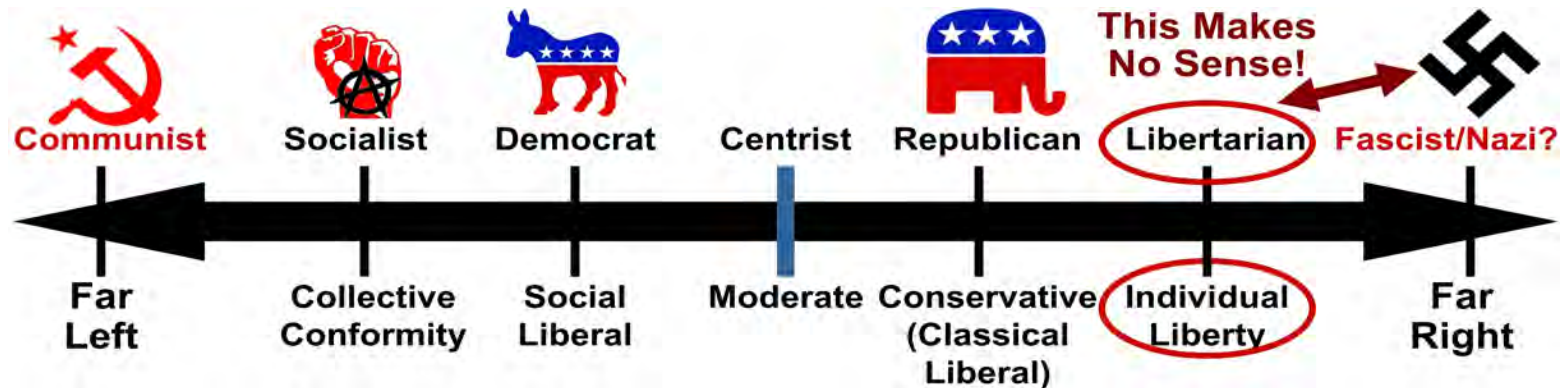

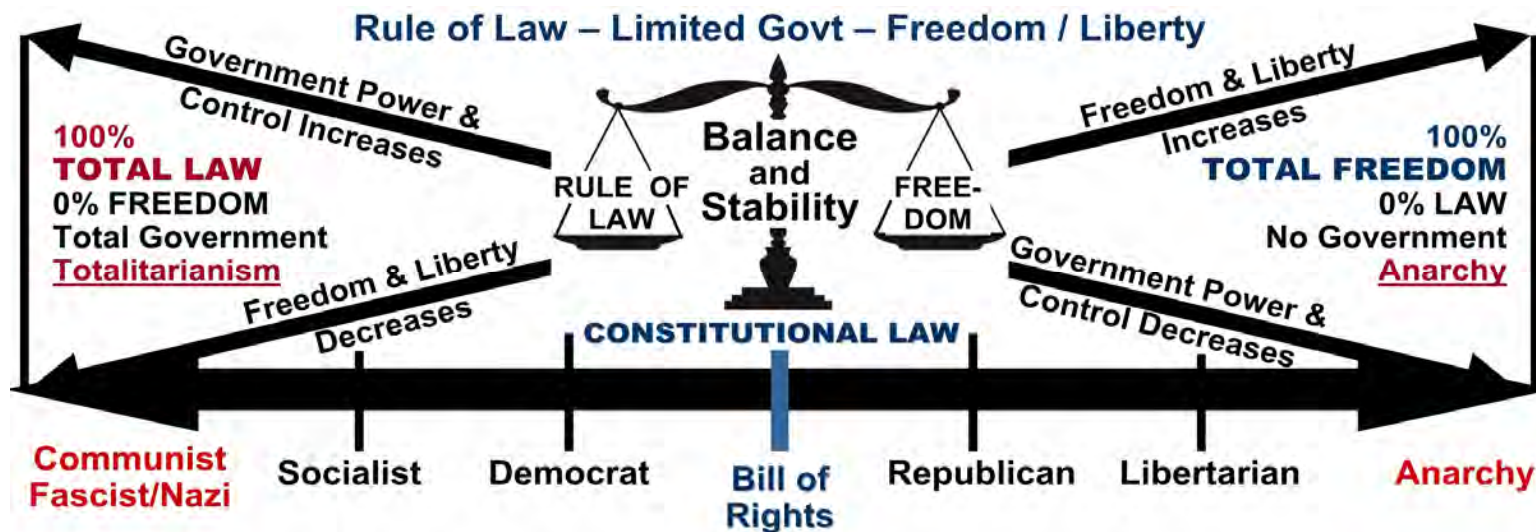

## SEPARATION OF POWERS "CHECKS-AND-BALANCES"

### Legislative

- Writes and enacts laws
- Enacts taxes, authorizes borrowing, and sets the budget
- Has sole power to declare war
- May start investigations, especially against the President
- The Senate confirms presidential appointments of federal judges, executive department heads, ambassadors, and many other officers, subject to confirmation by the Senate
- The Senate ratifies treaties
- The House of Representatives may impeach, and the Senate may remove, executive and judicial officers
- Creates federal courts except for the Supreme Court, and sets the number of justices on the Supreme Court
- May override presidential vetoes
- Polices its own members

- PROBLEM! -

'POLICING OWN MEMBERS'  
BECOMES IN EFFECT A  
'CONFLICT OF INTEREST'

### Executive

- May veto laws
- Vice president presides over the Senate
- Wages war at the direction of Congress (Use of Force—Congress must declare and authorize)
- Makes decrees or declarations (for example, declaring a state of emergency) and promulgates lawful regulations and executive orders
- Influences other branches of its agenda with the State of the Union address
- Appoints federal judges, executive department heads, ambassadors, and various other officers
- Has power to grant pardons to convicted persons
- **Executes and Enforces the Law. (a 'KEY Function' which is under political control)**
- Polices its own members

- PROBLEM! -

**THE ONLY TWO FUNCTIONS OF GOVERNMENT** which involve the authorization of **the use of force**—potentially deadly force—are **the military**, and **the law enforcement**.

### Judicial

- Determines which laws Congress intended to apply to any given case
- Determines whether a law is unconstitutional. (The power of judicial review is not expressly granted in the Constitution, but was held by the judiciary to be implicit in the constitutional structure in Marbury vs. Madison (1803).)
- Determines how Congress meant the law to apply to disputes
- Determines how a law acts to determine the disposition of prisoners
- Determines how a law acts to compel testimony and the production of evidence
- Determines how laws should be interpreted to assure uniform policies in a top-down fashion via the appeals process, but gives discretion in individual cases to low-level judges (The amount of discretion depends upon the standard of review, determined by the type of case in question.)
- Polices its own members

- PROBLEM! -

**When the Executive Branch with the political control over federal law enforcement becomes corrupted, and the laws are not enforced on those in positions of political power—or to serve those with political power—you have tyranny.**

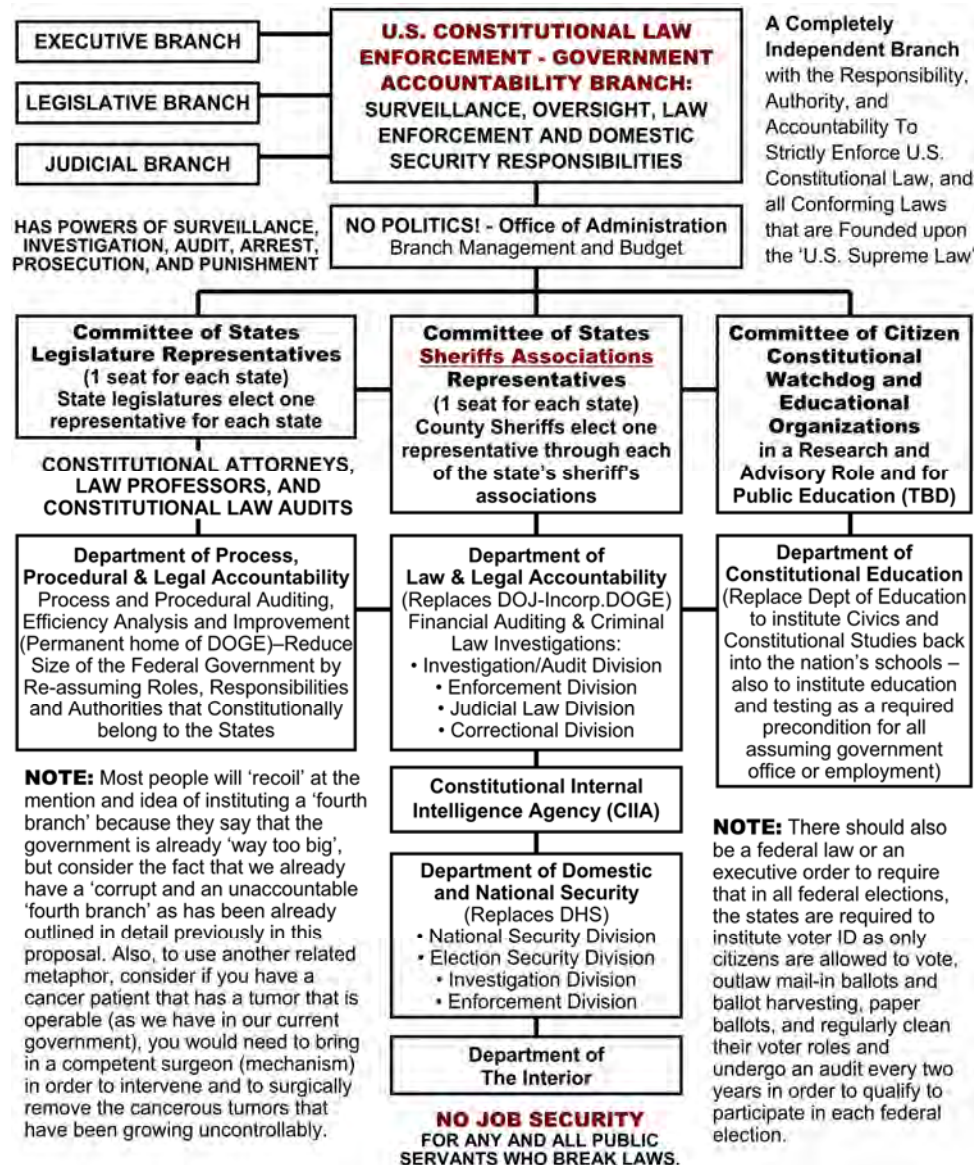
## THE SOLUTION CONCEPT PROPOSAL - SUGGESTED STRUCTURE

- Pass a test of knowledge and understanding of Constitutional Law, basic civics, and ethics.
- No dual citizenship allowed.
- No politics or political affiliations allowed on or off the job.
- Maintain financial transparency.
- No position or job security for breaking policies, rules, and violating laws.
- Discipline and accountability strictly maintained.

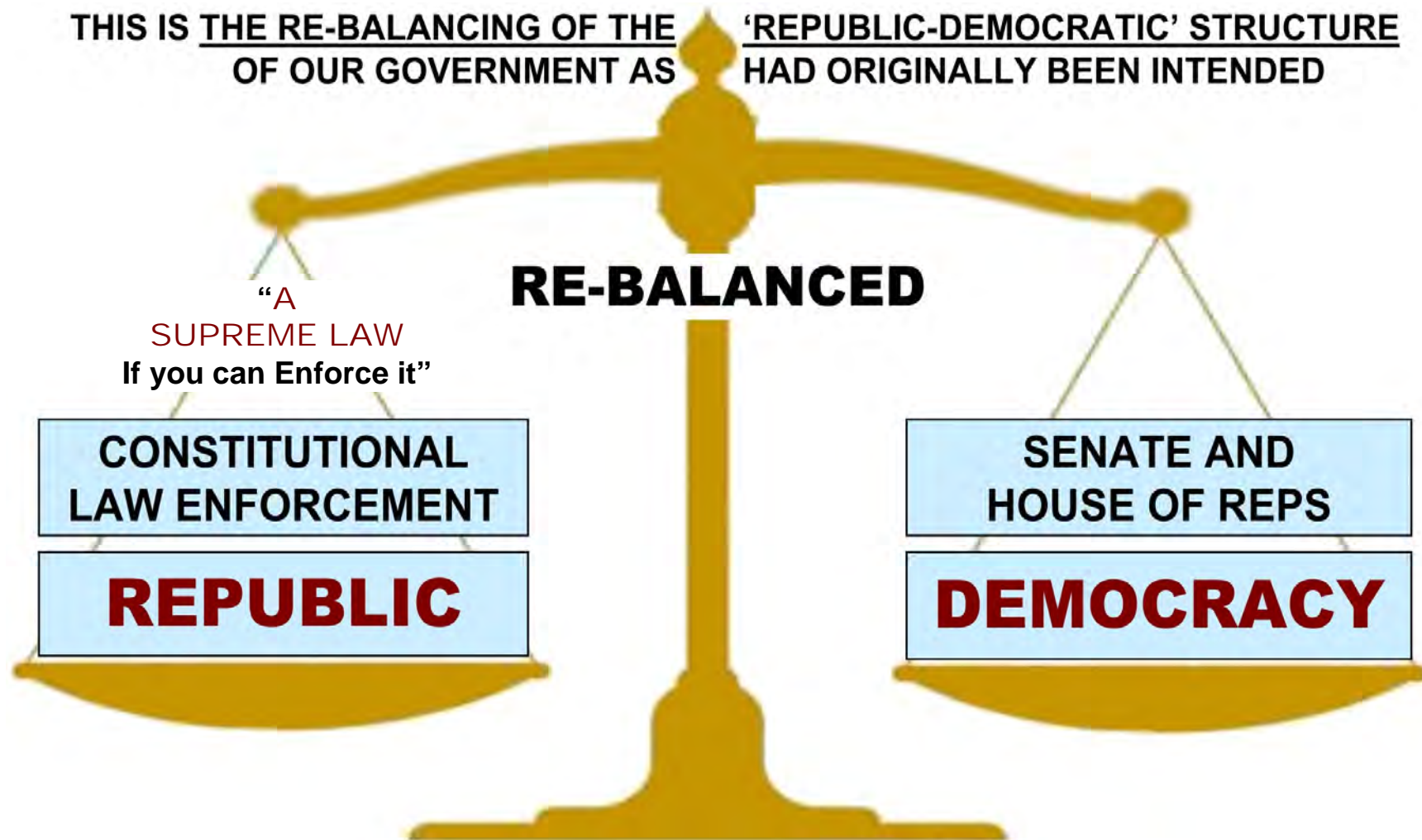

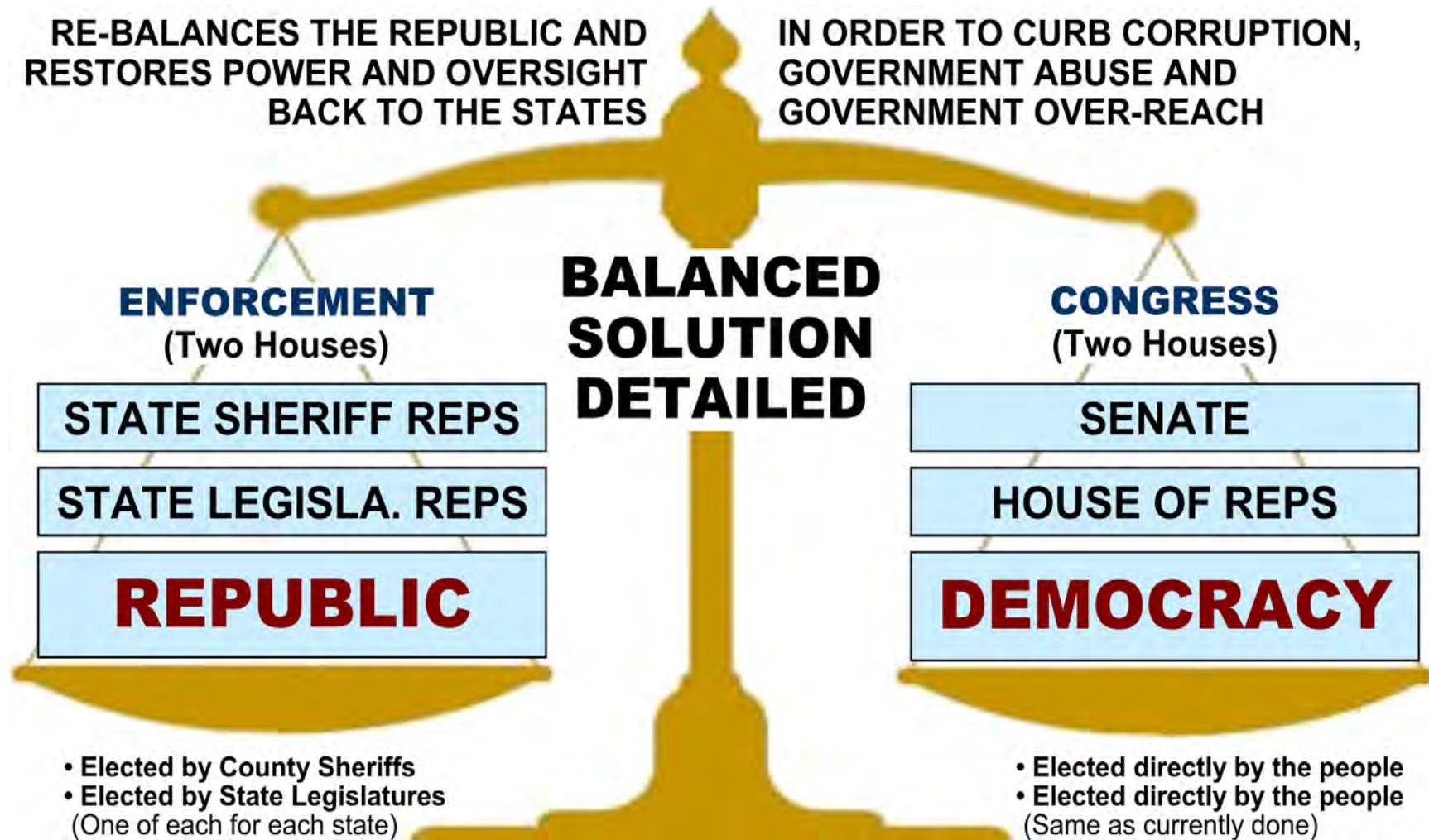

## COUNTY SHERIFFS ELECT STATE & FEDERAL REPRESENTATIVES THROUGH ASSOCIATIONS



**Examples from which one current or former sheriff for each county can be elected through the state associations for each state to serve at the state level law enforcement branch, and one current or former sheriff through each of the 50 state associations to serve at the federal level law enforcement branch facilitated through the National Sheriff's Association.**

Since each of the county sheriffs are elected directly by the people to represent the interests of their electorate at the local-level, and through the various state associations, representatives are elected to serve at both the state and the federal levels, it serves to merge the democratic process at the local level, and facilitates and helps restore the Republic process and brings forward local concerns at both the state and federal levels.



The fact that County Sheriffs are elected by their law enforcement peers to serve at the state-level, and also elected to serve at the federal-level by their peers through the state associations facilitated by the national association would help correct and offset the republic-democratic imbalance that was instituted via the 17<sup>th</sup> Amendment when the states sacrificed the Republic part by allowing their senate representatives to be elected directly by the people like the House instead of from their legislatures.

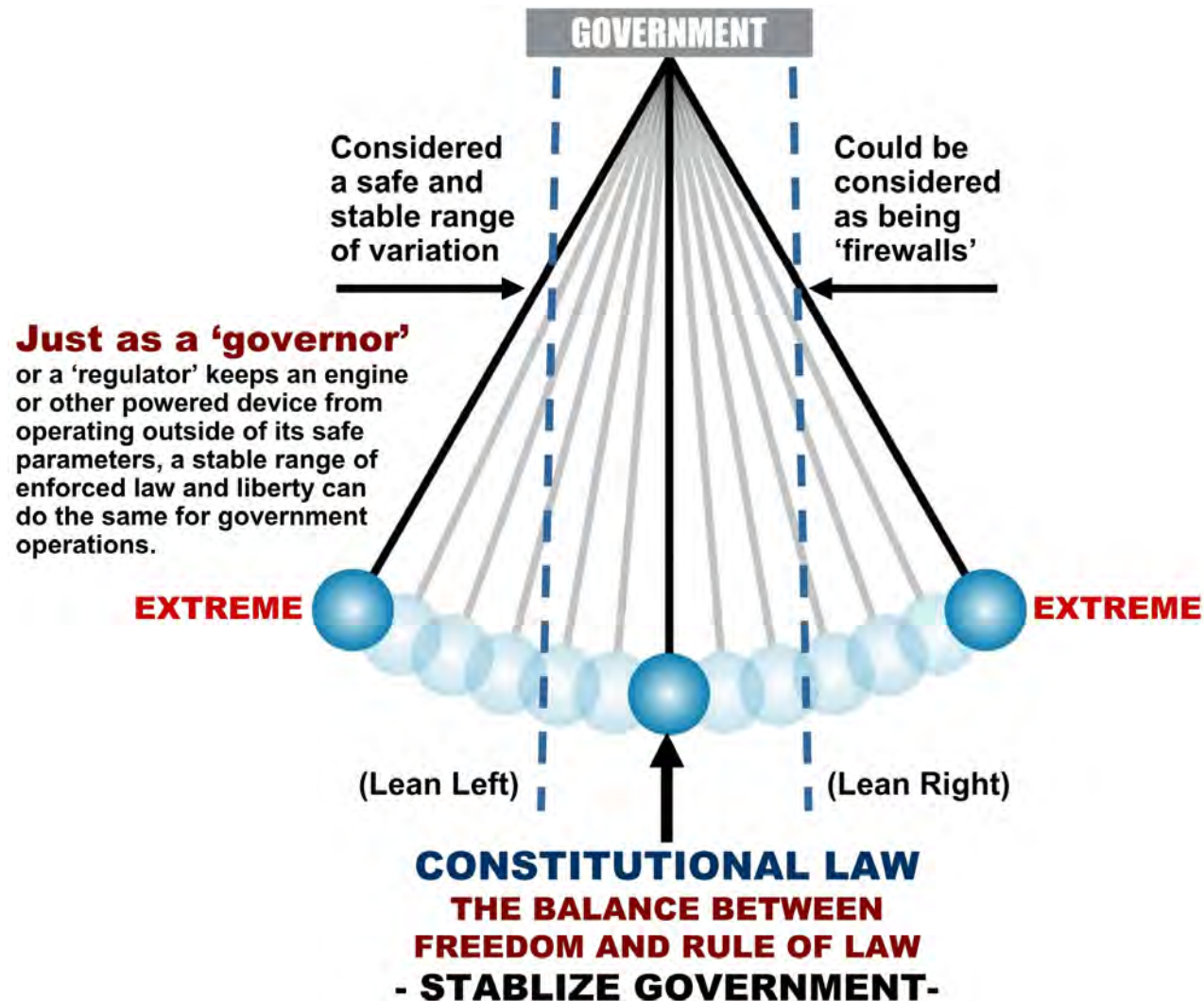
