CONSTITUTIONAL LAW 101 – SOVEREIGN

What is a “Sovereign”?

TO: all County Sheriffs and all U.S. Marshals

FROM: *We Be People*

cc: all Federal and State elected and appointed servants

RE: Your Duty to know and enforce the Law

“In United States, sovereignty resides in people. The Congress cannot invoke the sovereign power of the People to override their will as thus declared.” Perry v. US, 294 U.S.330

Confirmatio Cartarum *“sovereign People shall not be taken, or imprisoned, or disseised, or outlawed, or exiled, or anywise destroyed...but by lawful judgment of his peers or by the law of the land.”* Magna Charta, Chapter 39

High Treason: [Blacks Law 4th] Treason against the king or sovereign.

“It will be admitted on all hands that with the exception of the powers granted to the states and the federal government through the Constitutions, the people of the several states are unconditionally sovereign within their respective states.” Lansing v. Smith, 4 Wendell 9, (NY) 6 How416, 14 L. Ed. 997

“The doctrine of Sovereign Immunity is one of the Common-Law immunities and defenses that are available to the Sovereign. Sovereignty itself is, of course, not subject to law, for it is the author and source of law; but in our system, while sovereign powers are delegated to the agencies of government, sovereignty itself remains with the people, by whom and for whom all government exists and acts And the law is the definition and limitation of power...” Yick Wo v. Hopkins, 118 US 356, 370 and Terry v. Ohio, 392 US 1, 40

“The people of this State, as the successors of its former sovereign, are entitled to all the rights which formerly belonged to the King by his prerogative.” Lansing v. Smith

“‘Sovereignty’ means that the decree of sovereign makes law, and foreign courts cannot condemn influences persuading sovereign to make the decree.” Fire Ins. Co. of Moscow, Russia v. Bank of NY. & Trust Co.

“The state cannot diminish rights of the people.” Hurtado v. People of the State of California, 110 U.S. 516.

To presume that a sovereign forever waives the right to exercise one of its powers unless it expressly reserves the right to exercise that power in a commercial agreement turns the concept of sovereignty on its head. Merrion et al., v. Jicarilla Apache Tribe et al.

“It is the public policy of this state that public agencies exist to aid in the conduct of the people's business.... The people of this state do not yield their sovereignty to the agencies which serve them. ...at the Revolution, the sovereignty devolved on the people; and they are truly the sovereigns of the country, but they are sovereigns without subjects...with none to govern but themselves.....” CHISHOLM v. GEORGIA (US)

CONCLUSION: When one of “We the People” is accused by law enforcement agents of being a terrorist because they acknowledge that they are a sovereign, that law enforcement officer engages in high treason. When a judicial officer incarcerates one of “We the People” because they are sovereign, that would be subversion against “We the People of the United States of America”. Our founding fathers were sovereign, so are we and so are you. Any elected or appointed servant who targets Liberty minded People because they are sovereign is a tyrant, they are the real terrorist and they are the ones who should be arrested for terrorism. People who claim to be sovereign and assault or kill police officers are criminals and murderers. We are not aware of any “sovereign group” in American that are terrorists, it is a fabrication by the enemies of Liberty that are destroying our courts and our Republican form of government.
